## October Luncheon

Our [second luncheon](#)

of the year is scheduled for Tuesday October 19th on "Building a Self-Maintaining Security Organization." The presentation will be given by Michael Santarcangelo - CISSP, President of Tech Valley ISSA & lead instructor for the (ISC2) Common Body of Knowledge CISSP.

Michael J. Santarcangelo, II, is the founder and president of The Michaelangelo Group (TMAG), a professional services and training company that focuses on solving information security business problems and applying the appropriate technology. Mr. Santarcangelo's primary expertise and experience are in the areas of policy development, privacy and compliance issues, wireless technologies, and security awareness.
